Whether addressing childhood obesity by bringing healthy food closer to home for the nearly half-million children living in Alabama communities with limited access to fresh, healthy foods or closing educational achievement gaps by increasing access to high-quality Pre-K for Alabama four-year-olds, for more than 20 years VOICES for Alabama's Children has represented the interests of children at the policy and decision making level of state government. We promote researched-based policy solutions that move us closer to the kind of Alabama we all want for our children. Other historical successes include the requirement of criminal background checks for school personnel, strengthening of the state's child passenger safety law and revision and improvement of the state's
